General terms and conditions of business

Company T-EXO GmbH

1. Validity of the conditions

The services, offers and deliveries of T-Exo GmbH are carried out exclusively on the basis of these terms and conditions. Deviating or conflicting conditions of the customer are hereby rejected. Extensions, changes or side agreements are only effective by written confirmation.

2. Rental object

All furniture, devices and other accessories listed in the order confirmation are rental object. The tenant receives this for ordinary use.

3. Rental period

The tenant is only made available to the tenant for the agreed purpose and period. If the rental period is not complied with, the landlord is entitled to invoice an additional, newly calculated rent. The landlord's claims for further claims for damages remain unaffected.

4. Prices

The landlord's offers are non-binding and are only effective by a written confirmation by the landlord. All rental prices are net prices and understand themselves without any deduction and plus the applicable statutory VAT. Unless expressly agreed differently, the following services are not included in the rental price and are calculated separately:

- Delivery
- Assembly and disassembly
- Collection of rental furniture



5. Delivery and return

The rental furniture is not delivered and made available at any explicit appointment before the start of the event. After the event deadline, these will be recovered by the landlord in good time. The tenant has to provide the rental object ready to collect. If the back of the tenant prevents the rental object from the tenant through culpable behavior, the landlord is entitled to invoice the additional effort. Self-collectors are pointed out that the rental object may only be transported in suitable, closed vehicles. If the payment is delayed, the landlord is entitled to refuse the delivery of the rental object or to recover prematurely delivered rental object.

6. Liability & use

If the rental object is damaged or lost, the tenant can be used in the amount of the replacement value. The tenant can also be used in the amount of the repair effort as long as it does not exceed the replacement value. Claims of the landlord on further default damage and the payment of the rent remain unaffected. The liability of the rental object begins with the takeover by the tenant and ends with the return from the landlord. The liability of the rental object for trade fair orders begins with the delivery to the booth and ends with the return from the exhibition stand, even if it is not occupied. If no other return date has been agreed, liability ends 24 hours after the event. The landlord for property and personal injury caused by the use of the rental object is excluded, unless the landlord meets intent or gross negligence.

7. Insurance

The rental object is not insured and the tenant is obliged to insure it against theft. The landlord immediately requires proof of the insurance.

8. Cancellation

Orders can be canceled up to 14 days before the event or the agreed delivery date. If you resign later, you have to pay the full rent. However, if it is not possible to restore, the customer only has to bear the costs incurred at the time. If the landlord cannot do an equivalent or higher -quality replacement, the tenant has the right to withdraw from the justified complaint.

9. Place of jurisdiction

The place of performance for tenants and landlords is the seat of the landlord. If the tenant is a merchant, the seat of the landlord is also a place of jurisdiction. The legal form of the Federal Republic of Germany is decisive, this also applies to business with foreign accounts.
